Twitchell Operations Committee (TOC) TOC – Director Conrad: nothing more beyond agenda items as listed; Director Adam: scoring on RFP took some time but got resolved; Director Hadick: no comments.

ACTION ITEMS

Retention of Frank W. Mullen for Additional RFP Scoring Services
Director Conrad: "insurance policy" to get scoring in because MNS hadn't
produced it yet; Director Sharer: rational action, but now that we have

ROC system is strong enough to pull up coke in oil wells; faster; won't damage inlet structure; no damage to roadway, because huge transports not needed; ROC does not need land use agreement; endorsements that other contractor does not have; have prior dam work experience; worked in several FEMA areas across the country; if you have questions, get an engineer to look at the technology; table the issue until an assessment of methods can be completed and provided.
